The **"Tax Personality of the Year"** award aims to recognize individuals and organizations who, through their dedication and leadership, have made significant contributions to the implementation of new tax regulations that positively impact taxpayers globally. This award also values contributions toward educating people on the importance and benefits of tax competition, as well as the preservation of strong property and privacy rights. This recognition aligns with the objectives of The 1841 Foundation to promote tax competition, privacy and property rights, and educate the global community on these critical topics.



I. Significant impact:

The individual to be recognized must have significantly influenced the development, approval, and/or implementation of tax regulations that have effectively been adopted at the municipal, regional, national, or international level, and that align with the foundation's mission to promote tax competition and protect privacy and property rights.

2. Innovation and leadership:

The candidate's ability to introduce innovative and effective approaches to tax regulations will be evaluated, along with their skill in leading meaningful changes that foster healthy tax competition.

3. Community contribution:

The individual must demonstrate a consistent commitment to improving the taxpayer community, promoting fairness and transparency in tax systems, in line with the foundation's values.

4. Evidence of results:

Tangible and measurable results of their actions must be presented, reflecting the positive impact of their efforts, such as improvements in tax competition, relief for taxpayers, among other outcomes.

5. Recognition and reputation:

The individual should have a strong reputation in the tax field, with a record of recognized achievements and respect for their contributions to the sector.



I. Nominations:

Nominations will be accepted from **professionals**, **organizations**, **and members of the tax community** who wish to propose candidates that meet the established criteria.

2. Jury evaluation:

A jury composed of tax experts and representatives from The 1841 Foundation will review the nominations and select the awardee based on the established criteria.

3. Winner announcement:

The winner will be announced through The 1841 Foundation's digital platforms. A piece of artwork by artist Daniel Genovesi, specially designed for the occasion will be gifted to the awardee and an announcement highlighting their achievements and contributions will also be published.

4. First edition:

Until the award achieves international recognition, the determination of the winner will be made by the foundation's board, with the announcement taking place at the Tax Annual Summit for the respective year. This mechanism is expected to apply to the awards for 2024, 2025, and 2026.

BENEFITS FOR THE WINNER

I. Public recognition:

The winner will receive recognition at events, publications, and digital platforms of The 1841 Foundation, in alignment with our mission to promote tax competition and protect privacy and property rights.

2. Visibility and influence:

Increased visibility and impact of their work at an international level, highlighting their contributions to improving tax regulations and protecting fundamental rights.

3. Keynote speaker:

The winner will be invited to deliver the closing keynote at the Tax Annual Summit, where the award will be presented. Their participation is not mandatory nor a condition for receiving the award.

4. Honorary membership:

The winner will be accepted as an Honorary Member of the foundation, joining past speakers and other notable figures.



Starting in 2027, nominations will be accepted until June 1st of each year.

The award will be presented initially at the Tax Annual Summit, which takes place on the third Thursday of November each year.
